IT industry is in the top of Moldovan Government priorities, it is the fastest growing industry, offers highest salaries, employs youth and creative people, and digitally transforms the entire society






ICT SECTOR SALES EVOLUTION (MLN. MDL)






ICT EXPORTS EVOLUTION (MLN. MDL)


























































































- ✓ Increasing the competitiveness of small and medium enterprises in the field of information technology by facilitating access to non-reimbursable financing)




DIGITAL ECONOMY ROADMAP
